Privacy is at the core of WybeAir. We understand how important privacy is and will always be transparent about how your personal information is being used and/or processed. This privacy policy explains how WybeAir uses your personal data on our **Discord Bot**.

Which personal identifiable data does WybeAir collect?

First name and last name

- Used during registration on Vamsys, linked to your username but not publicly visible within Discord.
- Used for authentication within our Discord server.

Username

- Used for authentication, and visible throughout WybeAir's Discord server.

How does WybeAir collect your data?

We collect data and process data when you:

- Authenticate on Discord

How will we use your data?

WybeAir collects your data so that we can:

- Permit access to our Discord server.
- Update your rank Discord role.

How do we secure your data?

We value your trust in providing us your Personal Information, thus we are striving to use commercially acceptable means of protecting it. But remember that no method of transmission over the internet, or method of electronic storage is 100% secure and reliable, and we cannot guarantee its absolute security.

Data protection rights

- *The right to data portability* – You have the right to request that WybeAir's transfer the data that we have collected directly to you.
